



- Wear lightly colored or reflective clothing at night and brightly colored clothing during the day.
- Stay in well-lit areas, especially when crossing the street.

STAY ALERT



- Put down your phone. Smartphones and hand-held electronic devices are a daily part of life, but they take your eyes off of the road and distract your attention.

Don't wear headphones. Your ears will tell you a lot about what is happening around you - be sure to use them.

FOLLOW THE RULES

- Know and follow all traffic rules, signs and signals. You need to be aware of the rules vehicles around you must follow to properly anticipate what drivers will do.
- Never assume a driver will give you the right of way. Make every effort to make eye contact with the driver of a stopped or approaching vehicle before entering the roadway.

Summer Potluck Recipes - BLT Dip

Total Prep Time: 10 minutes

INGREDIENTS:

- 2 cups (16 ounces) sour cream
- 2 cups mayonnaise
- 2 pounds sliced bacon, cooked and crumbled
- 6 plum tomatoes, chopped
- 3 green onions, chopped
- Additional crumbled cooked bacon and chopped green onions, optional
- Assorted crackers, pita bread or chips

DIRECTIONS:

In a large bowl, combine the sour cream, mayonnaise, bacon, tomatoes and onions. Refrigerate until serving. Garnish with bacon and onions if desired. Serve with crackers, pita bread or chips.

*can substitute bacon crumbles for freshly cooked bacon or turkey bacon. For a healthier option, can also substitute sour cream for plain Greek yogurt.
