



Stars: There are 50 white stars on the American flag, representing the 50 states.


Stripes: There are 13 red and white stripes on the American flag, representing the original 13 colonies.

Is Texas an At-Fault State?

Generally states are divided between two major types of insurance law, "fault" states" and "no-fault states." Texas adopts a fault-based system of personal injury recovery. In simple terms, the party that is found to be at fault for an auto accident will be responsible for compensating the injured party. Payment is generally made through insurance companies. Under Texas' fault system, all drivers must carry minimum insurance amounts at all times:

- \$30,000 per person for bodily injury
- \$60,000 per accident for bodily injury
- \$25,000 for property damage

This basic insurance will pay for the other party's medical bills and property damage if you are at fault for an accident. Likewise, the other party's basic insurance will pay for your damages if he was at fault. You can also choose to pay for optional insurance coverage or higher amounts for additional protection.

Lemon-Infused Blueberry Ice Cream

July is National Ice Cream Month! If you're like most, you crave creamy, cold sweets like ice cream in the heat of summer. Check out this month's recipe:

INGREDIENTS:

- 2 cups coarsely chopped blueberries
- 2 tablespoons sugar
- 2 tablespoons water
- 1 (14-oz.) can sweetened condensed milk
- 1 (5-oz.) can evaporated milk
- 2 cups whole milk
- 2 tablespoons sugar
- 1 teaspoon vanilla extract
- 1/8 teaspoon table salt
- 2 teaspoons lemon zest

DIRECTIONS:

- 1. Bring blueberries, 2 Tbsp. sugar, and water to a boil in a small saucepan over medium heat; reduce heat to low, and simmer 10 minutes, stirring often. Cool 30 minutes; cover and chill 2 to 3 hours.
- 2. Whisk together condensed milk and next 5 ingredients; cover and chill 2 hours.
- 3. Pour milk mixture into freezer container of a 1-qt. electric ice-cream maker, and freeze according to manufacturer's instructions. (Instructions and times will vary.)
- 4. Remove container with ice cream from ice-cream maker, and freeze 30 minutes.
- 5. Stir lemon zest into prepared ice-cream mixture, and swirl in chilled blueberry mixture. Transfer mixture to an airtight container covered tightly with aluminum foil; freeze 3 to 4 hours or until firm.
